A Note from our Legal Programs Coordinator

As the Legal Programs Coordinator, I am responsible for navigating victims through the civil and criminal justice system. This includes, but is not limited to: helping victims prepare and file an order of protection; attending order of protection hearings; referring victims to local attorney's; accompanying victims to attorney's appointments; advocating for discounted rates from those attorney's; assist victims in filing for divorce on their own; accompany victims to court for divorce hearings; being a liaison between the victim and law enforcement

and/or prosecuting attorney; assist victims with Crime Victims Compensation and victim impact statements; accompany victims to court for criminal proceedings.

2012 proved to be a very busy year for legal advocacy. Over 750 legal advocacy services were provided in 2012, that is an average of two services provided daily, up from 550 legal advocacy services provided in 2011. So far, we are on track to meet or exceed last year's numbers.

CADV served 277 women, 6 men and 151 children in 2012. We provided 2369 bed spaces throughout the year.



New Challenges, New Solutions

Only 30 years ago, crime victims had no rights, access to crime victim compensation, or services to help rebuild their lives. They were often excluded from courtrooms, treated as an afterthought by the criminal justice system, and denied an opportunity to speak at sentencing. Yet through decades of advocacy and hard work, we have come a long way. Today, all states have enacted crime victims' rights laws and established crime victim compensation funds. More than 10,000 victim service agencies help victims throughout the nation. Every year, states and localities receive millions of federal dollars to support these services.

But National Crime Victims' Rights Week reminds us that many challenges remain. Crime victims' rights are not universal and are often not enforced. Only a small percentage of victims receive crime victim

compensation, which is usually limited to victims of violent crime. According to last year's National Crime Victimization Survey, more than 50 percent of violent crimes were not reported to police in 2006-2010. In addition, a 2011 report called the Use of Victim Services Agencies by Victims of Serious Violent Crime showed that only 9 percent of violent crime victims received needed services in the 1993-2009 timeframe.

Advocates also face a host of new challenges as they strive to provide culturally competent services for increasingly diverse populations (e.g., seniors, teens, immigrant populations) and victims of newly prevalent crimes (e.g., trafficking and technology-related stalking and identity theft). As funding sources decrease, providers must target their services even more strategically.

"New Challenges. New Solutions. captures our mission in the 21st century," said Joye E. Frost, Acting Director, Office for Victims of Crime (OVC), U.S. Department of Justice. "As reflected in OVC's major strategic planning initiative, Vision 21: Transforming Victim Services, we must craft a new vision for reaching all victims of crime. We can achieve this only by substantially broadening our thinking, strategically planning our future, and creatively expanding our resources and tools."

National Crime Victims' Rights Week will be held April 21-27 in communities throughout the nation. In Washington, DC, the U.S. Department of Justice will hold OVC's annual Service Awards ceremony that month to honor outstanding individuals and programs that serve victims of



crime. CADV will also observe National Crime Victims' Rights Week with special events and programs, including our annual Crime Victim's Rights Breakfast, April 25, doors open at 7:30 at the Church at Osage Hills. We Need More Help! Can You Lend A Hand?



CADV's volunteers have always been a critical factor in fulfilling our mission, and over 27 years later that fact remains even truer than before. Our volunteer roster is composed of people from all walks of life; some are men and some are women, some are fully employed and others are retired. One thing they all have in common however, is their compassion for others, their selflessness, and their willing to serve.

If you too have a compassionate heart and desire to help those in need, you might be a great fit to join our volunteer program. As our shelter and the number of victims we are serving continues to grow, we need to expand our volunteer corps in all areas. Some services that volunteers might provide are transportation, life skills

lessons, 24-hour hotline assistance, maintenance, fundraising and more. Two areas that we could use the most help in now are our Hospital Advocacy and Children's Programs.

Violence and crisis don't just happen during business hours. It can happen any day of the week, day or night. Therefore, it's important victims of domestic and sexual violence have access to services 24 hours a day, 7 days a week. As part of the Lake Area SART (Sexual Assault Response Team), CADV responds to the hospital emergency room whenever a victim comes in to be treated for injuries and/or have a sexual assault forensic exam done. We are in need of volunteers to take turns being on call each month to respond. You will be providing information about

available services and providing support. Adequate training will be provided to all volunteers prior to serving.

Do you love working with children? Would you like to help provide them with the safety, affection, and care they deserve? For children that have been victims of domestic violence, often the most basic care that children require is not provided. It is important that the children sheltered here receive the care and compassion they need to thrive and regain a sense of security or worth that may have been lost. You can help make that difference.

Volunteers are needed to provide child care Tuesday nights while their mothers attend support group.

The number of children and ages vary. Volunteers are scheduled in pairs, are asked to arrive by 6:15pm and stay until group commences, typically 8pm. You may choose to volunteer this service anywhere from 1-4 times per month.

In 2012, SART offered services to 39 domestic assault & 22 sexual assault victims from Camden, Miller and Morgan counties.



It has been another incredible year for the Clinical Coordinator and the counseling component at CADV. We have expanded our services to include Miller and Morgan Counties. Jill, our Clinical Coordinator, has secured a room in the community center in Eldon and offers counseling there every Wednesday. There is also a room available on Wednesday at Lake Ozark Christian

Church so that clients in the Lake Ozark area don't have to travel to Camdenton or Eldon for services. A room at the Morgan County Health Department is now available every Friday for counseling purposes.

Jill has been awarded the opportunity to accept two interns from two local colleges' counseling programs. With this addition to our staff, we are now able to offer counseling to the children of women who stay in the shelter. The combination of staff growth and community partnerships has allowed our counseling program to thrive more now than ever.

In 2010, CADV received a grant from the Missouri Foundation for Health (MFH), which allowed us to begin offering counseling services. On average 100 new women are being seen each year; totaling 300 women who have received counseling services over the course of the past three years. CADV is projected, based on last year's growth and numbers to date in 2013, to see a 28% increase in victims in need of counseling services. The MFH grant has ended and is not renewable, leaving a large black cloud hanging over the counseling department. Despite the gloomy forecast, the de-

partment is taking a proactive approach and continuing to strive towards ending the cycle of domestic and sexual abuse in our community.

Jill has been speaking to community organizations regarding CADV's services, as well as explaining the dynamics of domestic and sexual abuse. She offers a class to Jr. and High school students on Teen Dating Violence. She has facilitated this program at Horizons, School of the Osage, and Girl Scout meetings.
